All cameras must be of Weatherproof, Night Vision, WDR-120, and other latest facilities and can be accessible on any IP based NVR of any brand/make. Video data must be recorded in surveillance Hard Disk via NVR with minimum 30 days backup needed in Control Room. All post and Smart control room must be equipped with required electricity, power backup, networking setup, proper earthing, with proper optical/Lan wires in a managed way with proper security locks in all outdoor cabinets/boxes. All poles, outdoor cabinets/boxes must be fitted with proper pole mounting and as well as in suitable heights, for all weather easy maintenance work and these must be weatherproof. All materials/equipment used must be of approved Quality, Standard and make of global brand with service centre facility.

2. Eligibility Criteria:
